April 11, 2024 Koylton Twp Board Meeting

The regular Koylton Twp Board Meeting was called to order by Supervisor Doug Kramer @ 7:00 pm. Pledge to the flag. Board Members present: Kramer, Kelly, S. Boyl, Sabin & J. Boyl.
11 others were present.

In attendance were Robert Mantey & Deputy Dara Hood from the Tuscola County Drain Commission. They advised the Board that certain maintenance and repair was necessary to be performed on the Murdick-Vansickland Intercounty Drain and through Resolution asking for authorization to levy a special assessment.

Motion made by J. Boyl, seconded by Kramer to approve the Resolution for the Tuscola County Drain Commission pertaining to the Murdick Vansickland Intercounty Drain. Motion carried.

Supervisor Doug Kramer administered Oath of Office to Melissa Kelly as Clerk of Koylton Township.

Motion made by Kelly, seconded by J. Boyl to approve the minutes of the March 21, 2024 meeting as presented. Motion carried.

Motion made by Sabin, seconded by J. Boyl to approve the Treasurer's report for April 2024 with an ending balance in the general fund of \$415,524.14. Motion carried.

Motion made by Kramer, seconded by Sabin to approve the transfer of funds from the general fund to the garbage fund for money that was collected from delinquent garbage tax money in the amount of \$18,790.32.

Kramer stated he talked with the neighbors near the Siple Cemetery and there is no way they will agree to allowing the Tornado Siren.

Motion made by S. Boyl, seconded by Kramer to approve the 2 miles of Edgeline Pavement Markings in the amount of \$1,150.00. Motion carried.

Motion made by J. Boyl, seconded by S. Boyl to approve Road Work to be performed by the Tuscola County Road Commission in the amount of \$253,150.00. A check will be written for half and delivered to the Tuscola County Road Commission in the amount of \$126,575.00. Motion carried.

Motion made by S. Boyl, seconded by Kramer to accept Resolution #2024-05 of the Koylton Township Board in Recognition of Profound Appreciation of Distinguished Service by Mark Schank. Motion carried.

Supervisor Doug Kramer administered Oath of Office to Ashley Schank as Code Compliance Officer of Koylton Township.

Kramer stated that Evan Howard agreed to continue to mow the Siple Cemetery.

Doug talked to Corey and we will be receiving an updated contract for Hall Rental.

Motion made by Kelly, seconded by Sabin to purchase a computer for the CCO. Motion carried.

Motion made by Sabin, seconded by S. Boyl to have Rashel Hubbard design a logo for the township at a fee of \$200.00. Motion carried.

Kramer stated we need 3 members for the Board of Appeals. One member must be a board member and one may be a member of the Planning Commission.

Supervisor Kramer pursued DTE about a Franchise Ordinance but no one from DTE could answer his questions and didn't know what he was talking about.

S. Boyl read the definition of the Headlee tax amendment, Headlee override and Headlee Rollback. A "Headlee override" is a vote by the electors to return the millage to the amount originally authorized via charter, state statute, or a vote of the people, and is necessary to counteract the effects of the "Headlee Rollback."

Motion made by Kramer, seconded by Sabin to pay bills in the amount of \$18,917.64 for April 2024. Motion carried.

Motion made by S. Boyl, seconded by J. Boyl to adjourn at 9:18 pm. Motion carried.
